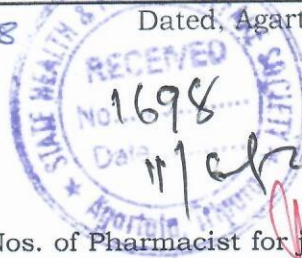

**Subject:-** Request to depute 10 (ten) Nos. of Pharmacist for jails for the next period of 3 (three) months to tide over the COVID situation at hand.

Sir,

With reference to the subject as cited above, it is to inform you that the Hon'ble High Powered Committee constituted in compliance of the order dated 23.03.2020 of the Hon'ble Supreme Court of India in Suo Muto writ petition (C) 01 of 2020 in re-Contagion of Covid-19 virus in Prisons held a meeting on 15.05.2021 by video conferencing. On discussion it has been decided that all possible steps should be taken for preventing the transmission of the deadly virus amongst the inmates in the prisons. Jail Department has been facing acute problems for want of health staff especially pharmacists. Out of 13 functional jails in Tripura there are only 04 (four) jails where pharmacists have been posted. So, it is felt strongly necessary to provide 01(one) pharmacist in every District Jails/Sub-Jails for ensuring proper health service to the inmates during 2<sup>nd</sup> Wave of Covid-19 pandemic situation, for at least the next 3 months.

As such, you are hereby requested, to kindly depute 10 (ten) Nos. of Pharmacist for jails for the next period of 3 (three) months to tide over the COVID situation at hand.

This has got approval by the Government under **U.O. No.1973/CM/2021 dated 29.05.2021.**
