During the period of deputation as stipend an amount of Rs 20,000/- will be paid to the candidate from concerned O/O the Chief Medical Officer from date of joining onwards. No leave facilities will be entitled during deputation period.

The candidates who will successfully pass-out would continue and posted subsequently as Community Health Officer at the HWC-SHC at deputed place. The candidates who will fail to qualify any of these exams will not be allowed to work in the system. However such candidates can appear one more time in the next term end examination conducted by IGNOU at their own cost.

Job Responsibility: The trained MLHP would carry out public health functions, ambulatory care, management and leadership at Health & Wellness Centre to successfully functionalise the following:

1. To implement National Health Programmes.
2. Administration and Management at HWC (or Sub Centre)
3. Health education and encourage awareness about Family Planning, Maternal Health and Child Health and Non Communicable Diseases.
4. Preventive, Promotive and curative care.
5. Identification of Dander Signs and Referral after pre referral stabilisation.
6. Implement Bio Medical Waste disposal guideline and infection control policies.
7. Supervision of Health Workers / front line workers for Maternal and Child Health, Family Planning and Nutrition related services.
8. Reporting (Online / Off Line) & Monitoring, Field Visit.
9. Others as assigned by the authority / government.
