  2. Written CAT exam & Viva-Voce test dates will be confirmed through Phone call / SMS / E-mail / Whatsapp of applicants given number.
  3. **Selected candidate(s) after Viva-Voce round will undergo training at the identified regional training centers in North East Region of India.**
  4. The authority reserves all the rights to cancel or delay the whole process at any time before or after interview without assigning any reason.
  5. **Final result will include training assessment marks and total marks given by the selection committee and final result of recruitment will be declared only after training period is completed.**
  6. During the training, selected candidates will receive Daily allowance and accommodation as per state Govt. rules.
  7. Candidates serving in Quasi Govt. Offices, Public Sector undertakings including Financial Institutions or Private Laboratory are advised to submit 'No Objection Certificate' from their concerned employer at the time of interview, failing which candidature may not be considered.

In case it is detected at any stage of recruitment that a candidate does not fulfill the eligibility criteria and / or that he / she has furnished any incorrect / false information or has conceal any material fact(s), his / her candidature will mark as cancelled.
