

2) **All the qualified candidates must produce following documents in original at the time of Personal Interview:-**


- PRTC as address proof in original
- Age proof document (Madhyamik Admit Card/Birth Certificate) in original.
- Photo ID card (EPIC/ Pan Card/ Aadhaar card/ Driving License) in original.
- All the relevant documents in support of required educational qualification (All Mark sheets & Pass certificates) in original.
- Original and authenticated experience certificate mentioning the period of service issued from the appointing authority in support of 2 (Two) yrs experience.
- Candidates working under Govt/Semi-Govt department/ Private or under corporation must produce their original **"NO-Objection"** certificate issued from their appointing authority.
- Candidates with MBBS/BDS/AYUSH/BSc Nursing qualification must produce valid Registration certificate issued from the Homoeopathic/ Ayurvedic/ Dental/ Nursing Council respectively &
- Candidates with MBBS/BDS/AYUSH qualification also need to produce one year rotational compulsory Internship completion certificate.
- In case of change in Name, Surname etc. original Affidavit need to be produced.


