



INSTRUCTIONS for all eligible candidates as per above mentioned list in the Table-A for appearing into the written examination:-

1. Candidates must bring the following documents to the examination centre on the day of examination:
 - a. Application receipt slip cum Acknowledgement slip
 - b. One original and valid photo id card (Votar ID card/ Pan card/ Driving License/ AADHAAR card)
 - c. Black/ Blue pen for written examination
2. General instructions:-
 - a. Reporting time:- Reach the examination centre well in advance. Candidate should report 30 minutes (Half hour) before their schedule examination time
 - b. All electronic gadgets (Including mobile phones, pagers, pen drive, Bluetooth devices etc.) and paper, books etc are strictly prohibited in the examination venue. No arrangement will be made at the centre for keeping any articles/ belongings to the candidates. If any of these items are found in your possession during the examination, it will be considered as unfair means and appropriate action will be taken.
 - c. Refusal to comply with the instruction will be treated as an attempt to disrupt the examination process and will attract disqualification and legal action.
 - d. The candidate is not permitted to make late entry or early exit from the exam centre. No candidate will be allowed to leave the examination hall without submission of their question paper cum answer sheet.
 - e. Candidate will use their own pen (Black/ Blue pen) for writing examination.
 - f. Only Application receipt slip cum Acknowledgement slip (Issued from O/o the CMO, Sepahijala), One valid ID card (Votar ID card/ Pan card/ Driving License/ AADHAAR card) and Black/ Blue pen are allowed inside the examination venue.
 - g. No TA/ DA will be given for appearing into the written examination.
- 3) Type of examination:
 - a. Duration of Exam: 01 (One Hour)
 - b. Type of question paper: question paper will be of 60 (Sixty) marks containing 60 (Sixty) questions. Each question will carry 01 (One) marks.
 - c. Medium of question: English
 - d. Candidates have to mark their answer in the question booklet itself. No additional sheet will be provided.
 - e. Every question will be followed by 4 (Four) answer option. Candidate will have to select their answer by encircling the right option.
 - f. For every correct answer 01(One) marks will be awarded
 - g. For every wrong answer and unanswered question 0(Zero) marks will be awarded
 - h. No negative marking will be there
 - i. Candidate marking more than one answer options (double/ multiple attempts) against one question will be treated as wrong answer and 0 (Zero) will be answered for that particular question.
 - j. Question paper will contains question mostly on General/ public health related, **Preventive medicine related**


