
Subject:- Enhancement of incentives to Primary Informer (ASHA, AWW etc) under the Maternal Death Review (MDR) intervention-regarding.

Under Maternal Death Review intervention, provision of incentives to primary informer i.e. ASHA/ AWW/Other for reporting of death of women (15 to 49 years) in the community within the laid down timelines is applicable as per MDR guidelines norms. To encourage & motivate frontline workers to report all such death the Government of India (vide Office Memorandum # M-12015/148/2011 MCH dated 13th February 2013) has decided to, enhance in incentive amount to the primary informers as laid down hereunder:-


