Cloud based e-Hospital^{@NIC} application is decided for roll-out to implement Hospital Information System (HIS) for internal work flow of hospital with technical support of Department of Electronics & Information Technology, Govt. of India empanelled e-Hospital Roll out agency for NE Region. In the initial phase of the project, twenty-one[21] Health institutions covering all Sub-Divisional Hospitals, District Hospitals, and State level Hospitals [GBP Hospital, IGM Hospital, Regional Cancer Centre & Moden Psychiatric Hospital] shall be taken on board in the centralised Hospital Management System (HMS) under National Health Mission (NHM).

2. In addition, Patient Feed-back System – ‘Mera Aspataal’ application is also decided for integration with all the District Hospitals after they are taken on board in the centralised HMS to allow multi-channel approach for information collection on patients’ level of satisfaction.

3. In this connection, Er. Rajat Bhattacharyya, Nodal Officer (IT), Directorate of Health Services, Agartala shall function as State Nodal Officer for e-Hospital^{@NIC} application for Health & Family Welfare Department, Govt. of Tripura including coordination with MoHFW for all queries related to integration with the Patient Feed-back System – ‘Mera Aspataal’ application in addition until further orders.


