## MEMORANDUM

In order to ensure programmatic coherence, efficiency besides bringing together related areas of Adolescent Health, Nodal Officers were declared at the State and District (undivided) level to lead the four adolescent centric programmes/ interventions namely Adolescent Reproductive and Sexual Health (ARSH), School Health Programme (SHP), Menstrual Hygiene (MH) and Weekly Iron and Folic Supplementation (WIFS) vide Memorandum of even No. dated 2<sup>nd</sup> March 2012 of Mission Director, NRHM and Special Secretary, Government of Tripura.

2. In view of new constitution and re-constitution of Districts, it has been decided to declare District Nodal Officer for Adolescent Health separately to lead the aforesaid four adolescent centric programmes/ interventions in their respective Districts. Accordingly, Nodal Officer for Adolescent Health at State and District level shall now be as under:-

(i) Nodal Officer for Adolescent Health at State level




