MEMORANDUM

Government has approved to release the yearly salary increment to all NHM employees as per approval by the Ministry of Health & Family Welfare (MoHFW), Government of India (GoI) in the RoP 2017-18.

Before releasing the salaries, the instructions as mentioned below may be followed:-

1. Received total gross salary including the Experience Bonus (EB) [as approved in RoP 2016-17] as on 31/03/2017 will be considered as present gross salary for the year 2017-18.
2. Increment of 8% (eight percent) will be calculated over & above the existing gross monthly salary (as per point-1 mentioned above) w.e.f 1st April 2017 for all those NHM contractual employees who have completed at least one year of service in his/her present post as on 31/03/2017, subject to approval of RoP 2017-18 (including Addendum) of the respective Programme Divisions.
3. All categories of staff who have newly joined in the FY 2017-18, will get only the present monthly salary as mentioned in their joining letter. Increment will not be entitled to them, until completion of one year of service in the same post.
4. Employees who will complete one year of service within FY 2017-18 will get 8% increment on existing salary from the month next to completion of one year in his/her present post.
5. The Salary for the month of September 2017 along with arrear payment @ 8% from 1st April 2017 calculated as described above should be released within 20th September 2017, positively. Calculation will be done by respective Finance/Accounts Personnel at State/District Offices & other Programme Divisions.

This Order will also be applicable to the employees of all Programmes Divisions under NHM Tripura subject to approvals in RoP 2017-18 (including Addendum).

This is issued as per Govt. approval vide U.O No-2214/Secy (H) dated 12/09/2017.

This will take immediate effect.
