MEMORANDUM

Subject: - Implementation of non-rotational posting of ANMs/GNMs/Nurses.

In order to ensure adequate numbers of trained human resources (ANMs/GNMs) at Delivery Points (DPs), the undersigned is directed to convey decision with respect to implementation of non-rotational posting as under:-


- (i) SBA and F-IMNCI trained ANMs/GNMs at the designated DPs shall serve on non-rotational basis to render special skills as per standard protocols and practices.

List of designated DPs is declared vide Memorandum No.F.3 (5-2596)-FWPM/SHFWS/2012 dated 18th November 2013.

- (ii) Rotation of trained ANMs/GNMs shall be subject to ensuring uninterrupted services and restricted within health facilities declared as DP. Completion of at least 1 to 2 years is pre-requisite in line with Sl.3 of the Notification vide No.F.3 (5-2674)-FWPM/SHFWS/2012/S-II dated 1st November 2013 (copy enclosed).

2. The State Programme Management Support Unit (SPMSU) shall from time to time coordinate with the Districts to provide updated list of trained GNMs and ANMs to concerned Directorates of Health Services and Family Welfare & Preventive Medicine for further validation and hosting of the same at public domain.



NOTIFICATION

The Governor, Tripura is pleased to notify the policy measures to augment the human resource in the Health Care Sector and to ensure rational deployment of available resources as follows:-

1. Priorities are to be given in posting of different categories of Health Care personnel in Health Institutions situated in rural areas.

Minimum 2(two) Medical Officers, 4-5 numbers of Staff Nurses, 1(one) Pharmacist 1(one) Lab. Technician & 6(six) G.D.As are to be placed in each PHCs.

2. Vacant posts of different Health Personnel will be filled up on getting concurrence of Finance Department from time to time.
3. Transfer of staffs are to be done on need basis. Medical Officers & other staffs in rural areas are to be transferred after completion of at least 1 to 2 years.
4. Medical Officers for Post Graduation studies on fulfillment of laid down criteria's are to be sponsored by the Health & Family Welfare Department. Amongst the criterias, 5(five) years duration of service with 3(three) years rural service including service in ADC area is a must .
