

- (i) Select district level NGOs.
- (ii) Facilitate the signing of MOU between the NGO and the District Health Society.
- (iii) Undertakes review meeting to assess performance of NGOs.
- (iv) Facilitates training programmes by NGOs.
- (v) Keep the State Health & Family Welfare Society and NGO Division, Govt informed about the selection and release of funds to NGO.

3. This is issued as per approval of Health & Family Welfare Department, Government of Tripura vide U.No.4078-Secy (HFW)/14 dated 06.02.14.


