MEMORANDUM

In accordance with the provision as laid down in Section 1.1.3 of Indian Medical Council (Professional Conduct, Etiquette and Ethics) Regulations, 2002 "No person other than a doctor having qualification recognised by the Medical Council of India and registered with Medical Council of India/State Medical Council(s) is allowed to practice Modern system of Medicines or Surgery. A person obtaining qualification in any other system of Medicine is not allowed to practice Modern System of Medicine in any form".

Further, in accordance with the provision 14(4) of The Tripura State Medical Council Act, 2010 "All Medical Practitioners are to be duly registered with the Tripura State Medical Council for practicing in the State of Tripura".

The Tripura State Medical Council (T.S.M.C) issued notices from time to time through Local News Papers and also served notices to different Health Care Institutions with request to the Medical Practitioners of State of Tripura and Medical Practitioners of out side the State of Tripura to register their names in Tripura State Medical Council for practicing in the State of Tripura. But some Medical Practitioners are yet to be registered and some are practicing in the State of Tripura after advertising in Local News Papers without registering at T.S.M.C.

Therefore, Medical Practitioners of Modern Allopathic System of Medicines, who have not yet registered at T.S.M.C, are reminded further and requested to register their names in Register of T.S.M.C. for practicing in the State of Tripura. Violation of the Regulations will be treated as Professional Misconduct as provided in Chapter-7 of the Professional Conduct, Etiquette and Ethics Regulations, 2002 of Indian Medical Council.
