MEMORANDUM

In modification of earlier Memorandum No. F. 10 (4)-SFWB/RCH/ 1997(2007), dated 31st August 2009, the undersigned is hereby to communicate the following Traveling Allowance (TA), Daily Allowance (DA) and Lump-sum Relocation Grant (RG) for all Contractual Staff of National Health Mission (NHM), Tripura:

1. Entitlement for Travelling Allowance (TA) on actual basis within the State, if no travelling arrangement is made by the Office:-

2. Daily Allowance (DA) may be allowed as mentioned below, if no accommodation & food bill is claimed:-

3. Lump-sum Relocation Grant (RG) may be allowed as mentioned below:-

5	Below Rs. 16,430/-	Rs. 800/-

The above RG will not be applicable for those NHM employees/ transferred cases which have been made based on their request letter/on mutual ground of the respective staff and relocations place not more than 8 km by road.

4. Allowance for carrying Personnel Effects during relocation, only on relocation to place more than 8 km by road:-

Sl. No.	Pay Structure	Rate per Km
1	Rs.56,701/- and above	Rs. 12/-
2	Rs.37,561/- to Rs.56,700/-	Rs. 8/-
3	Rs.22,141/- to Rs. 37,560/-	Rs. 6/-
4	Rs.16,430/- to Rs. 22,140/-	Rs. 5/-
5	Below Rs. 16,430/-	Rs. 4/-

The source of disbursement of these claims shall be authority from where the monthly salary of the employee is claimed. In case of relocation, the claim shall be disbursed from place of new posting. The application shall be submitted in the relevant State Government application format.


