### Roles and Responsibilities of Hospital Infection Control Committee (HICC):

- To ensure the proper conduct of sterilization and disinfection practices.
- Ensure that the Bio Medical waste management is being carried out as per BMW rules 2016
- Conduct Internal Surveillance of Hospital acquired infections.
- Develop and implement preventive and corrective Programmes Specific situations where infection hazards exist.
- Advice the Medical Officers on matters related to the proper use of antibiotics, to develop antibiotic policies and to recommend remedial measures when antibiotic resistant strains are detected.
- Review and update hospital infection control procedures from time to time.
- Help provide employee training regarding matters related to hospital acquired infections.
- To act on recommendations related to infection control, received from the administration, departments, services and other hospital committees
- To analyze and interpret data arising out of surveillance and reporting
- To recommend remedial measures and to ensure follow up action.
