
MEMORANDUM

It has come into notice that there is a shortage of some essential drugs in some of the health facilities in the State. In order to mitigate the shortage, supply orders have been placed but it may take some time to receive the stock and distribute to the facilities.

2. In view of the above situation, it has been decided that the Rogi Kalyan Samitis (RKSs) shall purchase essential drugs which are not available in their store, but are essential for treatment of patients to an extent of Rs.25,000/- for a period of one month only as one time grant. The fund shall be utilized only in case of emergency.

3. The additional expenditure of Rs.25,000/- by the respective RKS shall be met from the available RKS Corpus Grant of NRHM which shall be reimbursed from the State Budget in due course.

4. All concerned are requested to take necessary actions accordingly.


