



5. An amount of 5% of total ordered value shall be deposited within 20 (twenty) days as performance security, failing which the supply order shall be deemed to be invalid. Document of deposition of performance security shall be produced at the time of supply to the store keeper in-charge.
6. An amount @ 1% will be deducted from the bill/ invoice as late fee per week or part thereof for a period of 4 ( four ) weeks only, after which the supply order shall be treated as cancelled with forfeiture of earnest money and performance security .
