Subject: - Allocation of fund approved in ROP 2018-19.

Sir,

RoP-2018-19 has been received from Government of India and accordingly the necessary allocation for all Districts has been made from our end, which is **enclosed** herewith for your ready reference.

As per decision of the Executive Committee, SH&FWS, NHM Tripura, increment to all contractual staff allocated in following manner:

- 1. Common Increment (annual increment):-** The NHM staff who have completed one (1) year of service in their present post on or before 31st March, 2018 may be eligible to get 5% increment from 1st April, 2018. Those who are going to complete one year of service during the financial year 2018-19, may be eligible to get 5% increment from the succeeding month of completion of one year of service.
- 2. Increment on Rationalization with common increment (annual increment):-**

Sl. No.	Salary as on 31.3.18	% age of increment
1	Below Rs.20,000/- pm	6.49
2	Rs.20,000/- to Rs.29,999/- pm	2.00
3	Rs.30,000/- to Rs.39,999/- pm	1.00
4	Rs.40, 000/- & above	0.00

- 3. Experience Bonus (EB):-** The NHM staff who have completed three (3) year of service in their present post during the financial year 2017-18, are eligible to get 10% EB w.e.f. 1st April, 2018 on his/her existing salary as on 31st March, 2018.

Those who have completed five (5) years of service in their present post on or before 31st March, 2018 and received 10% EB in previous year are eligible for 5% additional EB w.e.f. 1st April, 2018 on his/her existing salary as on 31st March, 2018.




