Memorandum

In order to strengthen implementation & monitoring of Adolescent Health / Rashtriya Kishore Swasthya Karyakram (RKSK) components, it has been decided that **State & District WIFS Advisory Committee Vide. Memo. No. F3(5-2675)-FWPM/SHFWS/2012 dated :- 30th March, 2013** will act as State Committee for Adolescent Health (SCAH) & District Committee for Adolescent Health (DCAH) respectively. These committees will monitor the implementation & progress of all Adolescent Health issues & components (WIFS, Adolescent Friendly Health Clinic, Menstrual Hygiene Management, Peer Educator programme, Adolescent Health Day). The function of the committee will be to monitor the progress of the programme and resolve programmatic issues :

A. State Committee for Adolescent Health (SCAH) :-

- State Committee committee shall have to meet quarterly every year.
- Committee would monitor the following:-
 - Status of implementation of the programme & timeliness of completion of activity under the programme.
 - Facilitates Convergence.
 - Training.
 - Monitoring of implementation of WIFS programme .
 - Timely & adequate supply of IFA tablets.
 - Monitoring of implementation of Menstrual Hygiene Scheme in the implementing district(s).
 - Status of Adolescent Friendly Health Clinics in view of Adolescent Friendly Health Service.
 - Status of implementation of Peer Educator programme in the implementing district (s).
 - Status of Adolescent Health Day.
 - Provision OF of IEC and Counselling materials.
 - Ensuring Quality control.

State committee shall submit a monthly progress report on all Adolescent Health components to the Principal Secretary, H&FW, Govt. of Tripura.

B. District Committee for Adolescent Health (DCAH) :-

- District Committee would need to meet every quarter with participation of Health (MO I/Cs of PHC or CHC adjacent to the Block HQ), Education (Block Education Officers) and SW&SE (CDPOs) department.
- Committee would monitor the following:-
 - Status of implementation of the programme & timeliness of completion of activity under the programme.
 - Facilitates District & Subdivisional level Convergence.
 - Training.
 - Monitoring of implementation of WIFS programme .
 - Timely & adequate supply of IFA tablets.
 - Conduct yearly meeting with the Nodal Teachers for WIFS programme.
 - Status of Adolescent Friendly Health Clinics in view of Adolescent Friendly Health Service.


