MEMORANDUM

Government of India has decided to take up Community based maternal death review (CBMDR) and the Facility based maternal death review (FBMDR) which would help in identifying the gaps in the existing health care delivery systems, prioritize and plan for intervention strategies and to reconfigure health services. The overall responsibility of the Maternal Death Review (MDR) process lies with the state.

2. Accordingly, State Programme Officer (FW&RCH) has been designated as State Nodal Officer (SNO) for MDR and would fulfill the following responsibilities as under:-

- (i) Collect relevant data on maternal deaths from the district and carry out detailed analysis.
- (ii) Nominate the district level Nodal Officers.
- (iii) Facilitate the preparation of an annual maternal death report for the state and organize a dissemination meeting to sensitize the various service providers and managers. The annual report may contain typical maternal death case studies which may be used during the training of medical and paramedical functionaries.

3. The State Nodal Officer (SNO) would periodically place the findings of the detailed data analysis of the districts during Half Yearly Review Meetings of the State Level Task Force constituted for Maternal Death Review (MDR).


