
MEMORANDUM

Subject: Free Entitlements of Pregnant Women and New Borns under Janani Shishu Suraksha Karyakram (JSSK) Scheme.

In order to guarantee zero expense deliveries and zero expenditure treatment of sick new born in public health institutions alongwith the provision of free to and fro transport, Government of India has launched the **Janani Shishu Suraksha Karyakram (JSSK)** Scheme on 1st June 2011. The scheme entitles all pregnant women accessing public health institutions completely free deliveries including caeserian section with zero out of pocket expenses while for new borns an assurance of completely free treatment with nil out of pocket expenses during the first 30 days of their birth besides to and fro transport.


2. Since reducing the maternal and infant mortality is the key goal of Reproductive and Child Health Programme under the National Rural Health Misison (NRHM), it has been decided by the Government to implement Janani Shishu Suraksha Karyakram (JSSK) Scheme in all Government health facilities of the State by extending free diagnostics both Pathological, Radiography and other investigations like ECG, TMT etc., provision of supply of blood from Blood Banks at free of cost and exemption from all kinds of user charges from pregnant women and sick neonates irrespective of their economic status.

3. This is issued in line with the D.O. letter vide No.M-12015/90/2011-MCH dated 14th June 2011 of Special Secretary & Mission Director (NRHM), Government of India, Ministry of Health & Family Welfare, New Delhi and takes immediate effect from **15th August 2011.**




