

MEMORANDUM OF UNDERSTANDING

Between

Association for Social & Human Advancement (ASHA),
Damdamia

And

National Health Mission, Tripura

1. Purpose

With the object of promoting collaboration in Awareness campaign, Treatment & Research in engendering health and wellness of the people of Tripura, Association for Social & Human Advancement ("ASHA") and National Health Mission, Tripura individually also "Party" and collectively the "Parties", enter into the following Memorandum of Understanding ("MoU").

2. Forms of Collaboration


Within such fields as are mutually acceptable for the Parties, the following forms of collaboration, amongst others, may be pursued through a network of schools / institutions hereunder:

- 2.1 To collaborate with local PHC in order to bring about better health awareness and wellness among the children, parents and teachers.
- 2.2 To ensure health and wellness at schools through a trained nurse.
- 2.3 To create awareness among the rural villagers, about the advancement in the field of medicine and help reduce superstition about its unhealthy practices.
- 2.4 To create consciousness about issues concerning health and wellness among educators and all stakeholders of institutions.

3. Action Plan for Collaboration

Action plan for collaboration initiatives, for instance within such fields as described in section 2 above, between the Parties is agreed as under.

- 3.1 Each school/institution shall have a counselor and a nurse.
- 3.2 Identification of two teachers from each school for training for 5 days.
- 3.3 Conducting health programme on the day of parent teacher meeting at the school.
- 3.4 Campaign about the addiction to mobile and internet.
- 3.5 To identify and report issues of health to NHM.

- 3.6 Engage in the campaign such as Iron tablets, de-worming etc.
- 3.7 Use school premises to promote health and welfare.
- 3.8 Hostel administration need to ensure hygiene and health for the inmates.
- 3.9 Generate a data about absenteeism and its reasons of students and staff.
- 3.10 Forms will be given to fill the data of students. Also collect the absentees.
- 3.11 To create awareness about issues encountered by the young adolescence.

4. Financial Arrangements

- 4.1 Non-financial non-obligatory MOU in terms of no transfer of funds as such.
- 4.2 However, NHM will bear the cost of training of volunteers from ASHA.
- 4.3 NHM will arrange for any IEC materials which is required to be circulated among target population

5. General Coordinators

Each Party shall designate an administrative office to oversee and facilitate the implementation of collaborative activities arising out of this MoU. These offices are:

6. Liability

Except for loss or damages caused through gross negligence or intent, the Parties shall have no liability to each other hereunder.

7. Legal Relationship

This MoU shall be construed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the Parties. Nothing in this MoU shall create any legal relationship between the Parties.

8. Commencement, Renewal, Termination

This MoU will be effective from the date of the last signature hereto and will remain in force for a time period of five (5) years, with a possibility for renewal at
