

1. Quotation will be received in a single sealed cover containing both technical & financial bid addressed to the Mission Director, National Health Mission, SIHFW Building, Palace compound, Agartala, up to **5:00 PM on 15/05/2021** by the concerned bidder through speed post/Registered post/Courier Services/ by hand.
2. Quotations are likely to be opened on **17/05/2021** at 11:30 PM, if possible, in the Office of the undersigned. Name & address with phone no: of the tenderer and Reference number of the Short Notice Inviting Quotation should be mentioned clearly on the envelopes
3. Tenders received after stipulated date and time will summarily be rejected.
4. Following documents are required to be submitted for eligible in technical bid:-
  - a) Demand Draft as EMD amounting Rs. 2000/- (Two thousand only) (Refundable) from any schedule Bank, In favour of **State Health & Family Welfare Society , Tripura** payable at Agartala. Tender EMD will be exempted as per Govt. norms (DFPRT-2019) but relevant documents need to be produced.
  - b) PAN Card & GST Regn
  - c) Copies of Valid Trade License
5. If bid is submitted without any documents mentioned above, the bid will be rejected.
6. L1 bidder(s) will be selected among the technically qualified bidders.

7. Rates should be quoted both in word and figure. Overwriting or incomplete quotation will not be accepted. It is mandatory to quote all the above mentioned items, otherwise those bid will be rejected.
8. Payments of bill will be made after completion of supply. Admissible taxes will be deducted from the bill as per Govt. norms.
9. In case of legal dispute the jurisdiction will be the Tripura High Court, Agartala
10. The Mission Director(NHM), Government of Tripura, Agartala reserves the right to unilaterally terminate the contract or cancel the acceptance of the rate and firm at any time without notice before expiry of the period for which rates are now invited.
11. The Mission Director (NHM), Government of Tripura, Agartala also reserves the right to accept or reject Tender without assigning any reason thereof and Tender may be accepted or rejected in part or in whole.
12. 5% security money of the total order value submitted within 03 days after receiving of work order in favour of SHFWS, Tripura, payable at Agartala.
13. Refilling should be completed within 15 (Fifteen) days from the date of issue of work order. A penalty @ 1% on the total value shall be charged for every week or part of week of delay beyond stipulated date of supply for a maximum period of 03 (three) weeks after which order shall be deemed to be expired. However, Relaxation will be entertained only in special circumstances (Natural Calamities, War or any other situation beyond human control).
14. In case of any breach of contract the EMD/Security money will be forfeited.
