1. The rate shall be quoted in Rs. as per below format for 100 Kg per Km. The rate shall be inclusive of loading & un- loading charge, vehicle charge, fuel charge and other incidental charges. GST, if any admissible, should be mentioned separately, but not included with the rate. No over writing on the tenders shall be entertained.

2. The following documents shall be submitted along with the tender:-
 - a) Self attested GST Registration Certificate.
 - b) Self Attested Trade licence for carrying/transportation issued by the appropriate authority.
 - c) Self attested PAN card.
3. State Health & Family Welfare Society (SH&FWS) reserves the right to accept or reject any tender without assigning any reasons thereof.
4. Accepted tenderer shall be responsible for breakage, damage or loss of the item in transit.
5. No enhancement of the rate shall be entertained during the validity period of tender.
6. The rate for carrying will remain valid for 01 (one) year from the date of finalization. State Health and Family Welfare Society reserves the right to extend the validity period for further of 1 (one) year.
