Terms and conditions:

1. Quotation will be received in a single sealed cover containing both technical & financial bid addressed to the Mission Director, National Health Mission, SIHFW Building, Palace compound, Agartala, up to **2:00 PM on 22/01/2021** by the concerned bidder through speed post/Registered post/Courier Services/ by hand. Quotations are likely to be opened on **22 /01/2021** at **04:00 PM**, if possible, in the Office of the undersigned. Name & address with phone no: of the tenderer and Reference number of the Short Notice Inviting Quotation should be mentioned clearly on the envelopes.
2. Tenders received after stipulated date and time will summarily be rejected.
3. Rate should be quoted for all the items by the bidders.

4. Following documents are required to be submitted for eligible in technical bid:-
 - a) PAN Card
 - b) Up to date Trade License of the bidder
 - c) GST Registration
 - d) Signed SNIQ
5. If bid is submitted without any documents mentioned above, the bid will be rejected.
6. Rates should be quoted both in word and figure. Overwriting or incomplete quotation will not be accepted.
7. Admissible taxes will be deducted from the bill as per Govt. norms.
8. Payments of bill will be made after completion of supply as per specification of supply order. Triplicate bill submit along with 01 year warranty certificate.
9. In case of legal dispute the jurisdiction will be the Tripura High Court, Agartala
10. The Tender Inviting Authority, Government of Tripura, Agartala reserves the right to accept or reject Tender without assigning any reason thereof and Tender may be accepted or rejected in part or in whole.
11. Supply should be completed within 03(Three) days from the date of issue of supply order.
12. A penalty @ 1% on the total value shall be charged for every week or part of week of delay beyond stipulated date of supply. However, Relaxation will be entertained only in special circumstances (Natural Calamities, War or any other situation beyond human control).
13. 5% Security Money of total supply order should be submitted in favour of SHFWS, Tripura from any Nationalized Bank within 2 days of issuing work order. Security money will be released as per DFPRT2019/Manual of Procurement of Goods 2018.
