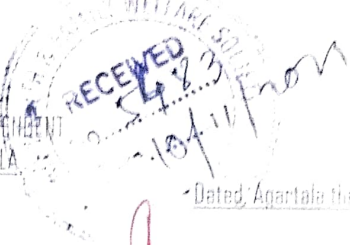

SPOT NOTICE INVITING QUOTATION

Quotations in sealed cover are hereby invited by the Medical Superintendent, IGM Hospital, Agartala, Tripura, from the reputed authorized suppliers/distributors or manufacturers, for supply of Hematoxylin Staining Solution(Harris's sol)-125ml x 20 bott for use in Pathology Dept. of IGM Hospital, Agartala.

Tender papers alongwith detailed informations may be collected from the office of the undersigned upto 12.30 P.M. of 11/11/2021 and will receive by this office through Register post / Speed post/ Courier Services/ by hand only upto 4.30 P.M. of 15/11/2021 & quotation will be opened on 16/11/2021 at 1.30 P.M. & during the bid opening session, interested bidders or his authorized representatives may remain present in the office of undersigned.

1. Tender should be submitted in single cover system, properly super scripted with Tender Title, enquiry no. and date alongwith bidders name, address & phone number & Bid shall contain submission of self attested Xerox copy of - (i) Valid Drug Licence along with trade license (ii) Copy of Pan Card (iii) GST registration certificate (iv) Upto date Professional Tax clearance certificate or copy of bank chalan (V) Original tender document (Tender enquiry) duly signed with full signature by the concerned bidder, as an acceptance of terms & conditions of the tender (vi) Declaration on a Non Judicial Stamp paper of Rs.10/-, regarding the firm has not been found guilty of malpractice or blacklisted/ debarred either by Health & family Welfare Deptt. Govt. of Tripura or by Drug Control Authority of the state or by any other state/ Central Govt. organization alongwith a declaration of the bidder, in a separate column, regarding the authenticity of the submitted documents or informations (vii) An undertaking of the tenderer stating that, if approved, they will execute the full supply of the ordered quantity & also abide by all the terms & conditions of the SNIQ. In case of supply of medicine, the time period between date of supply & date of expiry shall not be less then 01(one) year.

The bid shall also contain the complete technical specification/strength of the required items/medicines, for which rate is quoted Quoted items/medicine should be compulsorily with the name of Manufacturing firm (with full name & address) & it should be maximum with one alternative

2. Bid shall also contain the rates offered by the bidders. Rate should be quoted inclusive of all taxes. Basic price & taxes should be shown separately, alongwith all the details regarding compliance of terms & conditions. Supply of items/ medicines should be completed within 15 (fifteen) days from the date of issue of supply order & supply should be completed always on FOR door delivery basis.

3. In case of supply of medicine /item, if any item supplied, is found to be not of standard quality, the total quantity of sub standard batch supplied should be taken back & replaced by fresh stock at own cost of supplier irrespective of whether any part is consumed or not. Failure to supply the standard quality of drugs by the tenderer will render him disqualified for future supply.

4. A penalty @ Rs. 1% of total value should be charged for every week or part of week delay beyond the stipulated date of supply upto 02(two) week & after that period (period, delay beyond stipulated date of supply, upto 02 week) supply order will be treated as cancelled. However relaxation will be entertained only in special circumstances (Natural calamities, war or any other situation beyond human control).

5. No insurance charge or any other charges are admissible.


7. Income tax will be deducted from the bill at the time of payment as per Govt. rule if applicable.
